ORDER

1. The present petition has been filed by the petitioner-wife seeking transfer of Petition No. 132 of 2024 titled as "Virender Singh Vs. Roshi" pending before the Additional District Judge No.1, Rajgarh, Churu, Rajasthan to the Principal Judge, Family Court, Bhiwani, Haryana.
2. After hearing the learned counsel appearing for the parties, in our opinion, a case is made out for transfer of divorce proceedings as the petitioner has a minor daughter born from the wedlock and she is residing at Bhiwani, Haryana, which is more than 146 Km. away from Churu, Rajasthan. Two other cases filed by the petitioner are pending at Bhiwani.
3. Accordingly, Petition No. 132 of 2024 titled as

"Virender Singh Vs. Roshi" pending before the Additional District Judge No.1, Rajgarh, Churu, Rajasthan, is hereby transferred to the Principal Judge, Family Court, Bhiwani, Haryana.

4. Records shall be sent promptly by the Court where proceedings are pending to the transferee Court.

5. In case video conferencing facilities are available in the transferee Court, the parties may be permitted to appear through video conferencing on non-effective dates of hearings. As far as possible, effort may be made to list all cases between the parties on same date of hearing and these should be assigned to one Court, wherever, it has jurisdiction to deal with the matters.

6. Accordingly, the Transfer Petition is allowed.
