O R D E R

Heard the learned counsel appearing for the parties.

2. Leave granted.

3. The prayer(s) made in the present appeals is for grant of pre-arrest bail in connection with FIR Nos. 514 of 2024, 664 of 2024 and 719 of 2024 registered at Police Station, Thaliparamba, District Kannur Rural.

4. This Court vide order dated 23.10.2024 had granted interim bail to the appellants subject to deposit of certain amount.

5. It is not in dispute that the appellants had already deposited the amount of ₹42,00,000/- with the Trial Court.

6. Learned counsel for the complainant submitted that he was cheated for a sum of ₹60,00,000/-, at least, the amount deposited by the appellants may be released to him to which learned counsel for the appellants do not have any objection.

7. Since the amount of ₹42,00,000/- has been deposited by the appellants with the Judicial First Class Magistrate, Thaliparamba in respect of three different complainants, it is directed that a sum of Rs. ₹14,00,000/- in each case shall be released in favour of respective complainants in the three appeals, which are decided by this Court. The said amount be transferred in the bank accounts of the complainants upon furnishing necessary bank details before the Trial Court.

8. As the condition imposed has already been complied with by the appellants and the chargesheet has already been filed and further that it has noticed that the

investigation is complete, the interim order dated 23.10.2024 is made absolute subject to the condition that the appellants shall appear before the Investigating Officer as and when called upon and shall cooperate during trial.

9. The appeals are accordingly disposed of in the above terms.

10. Pending application(s), if any, shall also stand disposed of.
