O R D E R

After some arguments, learned counsel for the petitioner submits that only Rs.16,00,000/- (Rupees sixteen lakhs only) remains to be paid by the petitioner and the time granted has elapsed. It is submitted that the petitioner is ready to pay

to the complainant/respondent Rs.16,00,000/- (Rupees sixteen lakhs only) for which some more time may be granted.

2. On a query by the Court as to what time he requires, the reply is that the Court may grant him four more weeks. We find the said prayer to be reasonable.

3. Accordingly, the petition stands disposed of with a direction to the petitioner to pay the remaining Rs.16,00,000/- (Rupees sixteen lakhs only) to the complainant/respondent latest within four weeks from today. It is made clear that failure to do so will entail strict penal consequences as this order has been passed on the self undertaking given on behalf of the petitioner by the learned counsel to this Court.

4. It is further made clear that if the remaining amount, which is said to have been deposited by the petitioner, is still lying with any Court and has not reached the complainant/respondent, the complainant/respondent shall be entitled to receive the same from the Court where it may be deposited along with interest, if any, which may have accrued on the same.

5. Pending application(s), if any, shall also stand disposed of.
